

## Organisations Supporting Training (Climate Change & Leadership)

The organisations shown below are interested in supporting training around climate change. Each brief description highlights their focus whether by country of origin, stage in career, type of employer (government, NGO, private sector) or topic area.

In the first instance, it is crucial to identify whether your circumstances match the criteria set by the funding organisation. It is your responsibility to make the case as to why attendance at the Adaptation Academy will be beneficial.

The **Terra Viva Grants Directory** is an information service about international grant funding for agriculture, energy, environment, and natural resources in the developing world. Organisations supporting Climate Change are categorised by International Organisations; Government Organisations; and Foundations, Corporations, and Civil Society.

**Charles Wallace Open Visiting Fellowships**, offered under a partnership between the British Council in Pakistan and the Charles Wallace Pakistan Trust in the United Kingdom. Eligible candidates are Pakistani nationals, residing in Pakistan. They are normally junior or mid-career professionals or academics aged between 30 and 50, working in environmental sciences.

**Commonwealth Professional Fellowships** are typically three months but can be between one and six months in length, and can include limited time for attendance at short courses or conferences, as well as visits to other organisations. Note that Applications must come from an organisation in the UK. However the Fellow must be able to show how the knowledge and skills they will gain during the Fellowship will be disseminated after their return home; GCAP would require this information before making an application on behalf of a candidate.

**International Initiative for Impact Evaluation 3ie's Bursary Programme** offers funding for individuals to attend workshops and conferences related to impact evaluations and systematic reviews that can generate policy relevant evidence. They are targeted at researchers or policymakers in low and middle income countries with varying levels of experience.
